- Applicant must be Hong Kong legal residents
- Applicant aged between 3 and 14 years old would be given children membership. His/her parent or guardian should sign on the application form as guarantor. Applicant aged 15 years old or above would be given youth / adult membership.
- B: Procedure and Fees
- Any person intends to be member should contact the staff at reception counter in any one service unit to obtain an application form. Submit the completed application form to the reception counter of the Registering Service Unit (see top right corner). Present his/her Birth Certificate or HKID (either original or copy) and pay the membership fee. Membership would be effect immediately. Membership is valid for one year.
